



FILE YOUR TAXES FOR FREE WITH VITA

February 3 - April 15, 2025

The Volunteer Income Tax Assistance (VITA) program is a **free tax preparation service** for local Santa Barbara County residents who make **\$67,000 or less a year**. During the tax season of January through October, returns are prepared and electronically filed by the Internal Revenue Service (IRS)-certified volunteers for qualifying individuals or families. Volunteer tax preparers can assist with general tax information, tax preparation, and filing.

Required Documentation

- Proof of identification (driver's license, state photo ID or other government issued identification that includes a photo)
- Social Security cards for you, your spouse and dependents
 - Note: If you need to request a replacement card or update your Social Security record, go to Social Security number & card to find the best way to do this.
 - An Individual Taxpayer Identification Number (ITIN) assignment letter may be substituted for you, your spouse and your dependents if you do not have a Social Security number
- Proof of foreign status, if applying for an ITIN
- Wage and earning statements (Form W-2, W-2G, 1099-R,1099-Misc) from all employers
- <u>Social Security Benefit Statements (SSA-1099)</u>, if applicable

- Interest and dividend statements from banks (Forms 1099)
- Health Insurance Exemption Certificate, if received
- A copy of last year's federal and state returns, if available
- Proof of bank account routing and account numbers for direct deposit such as a blank check
- To file taxes electronically on a married-filing-joint tax return, both spouses must be present to sign the required forms
- Total paid for daycare provider and the daycare provider's tax identifying number such as their Social Security number or business Employer Identification Number
- Forms 1095-A, B and C, Health Coverage Statements
- Copies of income transcripts from IRS and state, if applicable

Self-filing is a good option for tax filers who are filing a current year tax return (2024), are comfortable using online tax software and want to learn how to file on their own, and who have earned less than \$67,000 in 2024.
